WHAT HAPPENED LAST MONTH MINUTES FROM Oct. 11, 2022 ZOOM MEETING

CLVN President, Diann Marsalek, called the zoom meeting to order at 7:06 p.m. CLVN will be holding Zoom Meetings until further notice of when it is safe to have in person meetings and until a location can be found to hold the meetings. Officers in attendance: Terry Diamond-Vice President, Mary Anderson-Corresponding Secretary, Jim Kink-Treasurer and Area Directors Dorothy Mroski, Dorothy Klees and Charley Wilcox. Officer excused was Area Director-Sharon Williams. A quorum was not present.

<u>President's Report:</u> Schedules for CAPS and CLVN 2023 meetings will be announced soon. Thanks to Terry Diamond, Mary Anderson and Jim Kink for their help with the summer movies. We will hold the November meeting on Nov. 15, 2022 instead of Nov. 8, 2022 which is Election Day.

Treasurer's Report: Jim Kink reported we have approximately \$17,798.00 in the Treasury. Our membership for 2022 was 114 which was a good recovery from the pandemic times. Dues for 2023 are now being accepted. We will be able to use a movie license that we paid for in 2022 for 2023 due to the cancellation of one of our movies. We had a net positive amount of \$950.00 in which our profit exceeded our expenses. We are also anticipating another movie sponsor to come in over the next few weeks. Diamond inquired if CLVN will be making a motion to approve an expenditure via a donation to the Lake View Food Pantry now called Nourishing Hope. This matter will be addressed at the November meeting. Marsalek commented in the past we had made donations either in one check or two checks split over a few months.

Nomination Committee Report: Marsalek reported all current officers will seek re-election for their positions for 2023. The election will be held at the Nov. 15 meeting. If anyone want to run for an office send an email to centrallakeviewneighbors@gmail.com.

<u>Beautification Report</u>: Marsalek reported Dorothy Mroski, Robin Greene and Marsalek planted about 500 spring tulip bulbs and are working on the corners. She thanked them for their efforts. Diamond commented the corners at Barry and Seminary looked very nice and clean.

Alderman's Report: No report.

Congressman Quigley Report: No report.

Senator Sara Feigenholtz report: Sen. Feigenholtz reported she likes to

hear what the neighbors concerns are while attending various meetings. Crime is very high on the list. She has walked the District with officers from the 18th and 19th Districts and heard about the decreased staff in the Districts. She knows the 19th District is busy with parades, concerts, Cubs games and entertainment areas. She visited the SDSC room at the 19th District and saw all the cameras in the District and license plate readers at work. She was able to secure funding of 1.4 million for more cameras and license plate readers for the two police stations which has helped solve crimes. Marsalek thanked her for her efforts to get the funding. A massive capital bill was passed so funding streams are constant for required projects. LSD is not a state highway and never was on any list for equipment. The law changed so now it is a highway and can get state resources. Emission testing is currently available in Skokie (12 miles from CLVN) after the site on Webster Street was closed by former Governor Rauner. A law was enacted for the EPS to conduct a study and report to the General Assembly. A new location should be open in Harwood Heights for emissions testing. Work is being done to address the Safe T bill which goes into effect on January 1, 2023. Work needs to be done before the effective date. Legislators are working with law enforcement to fix definitions and there are two trailer bills. She will also address any CTA flyover issues with Walsh construction and the CTA. Wilcox will get her a letter of concerns about concrete spalling and other issues. Send her any pictures about the CTA flyover and issues you see. She is also addressing the number of pigeons at the north side of the station. This veto session they will address assault weapons, and reproductive health of women.
